The following mechanisms designed to encourage and facilitate exchange of students are hereby established:

#### 1. OBJECTIVE

This Appendix is to detail out the practical issues for student exchange program in accordance with Section II of the Agreement of Cooperation signed by both parties, School of Dentistry, Aristotle University of Thessaloniki, Republic of Greece and Dental School, Okayama University, Japan.

## 2. STUDENTSHIP AND TUITION FEE

- (1) The students under this program should be at both graduate and undergraduate levels and shall be enrolled as non-degree exchange students at the host university.
- (2) While on the exchange program, the students shall be enrolled at the home university and obey the provision of the home university on payment of the tuition fees to the university.
- (3) The students shall be exempted from school fees for entrance examination, enrollment and tuition to the host university.
- (4) Exchange students interested in living in university housing will be provided assistance and information as far as possible in regard to accommodations. Exchange students, however, will be responsible for their own housing costs.

## 3. SELECTION OF STUDENTS

- (1) Both institutions agree to nominate students with high academic scores.
- (2) The students must be nominated by the home institution.
- (3) The host institution reserves the right to review the students nominated for this program and to deny their admission.

## 4. NUMBER OF EXCHANGE STUDENTS AND PERIOD OF EXCHANGE

(1) Under this program, each institution shall admit no more than 3 students in one academic year.

- (2) Each institution shall admit the student for a period within one academic year.
- (3) The host institution reserves the right to terminate his or her enrollment when the student commits willful misconduct.

## 5. ACADEMIC PROGRAM

- (1) The exchange students shall be permitted by the host institution to enroll for taking some credits and / or course of study.
- (2) The credits and / or course of study that the exchange students are going to take shall be approved beforehand by the home institution. The above credits shall also be authorized by the home institution.

## 6. SUPPLEMENTS

This Appendix shall be effective for the same period as the Agreement of Cooperation, and may be adjusted in writing upon mutual agreement of the two parties.
