



## Agreement Between Shenyang Aerospace University, China and Aristotle University of Thessaloniki, Greece

Party A: Shenyang Aerospace University

Party B: Aristotle University of Thessaloniki

In the spirit of mutual cooperation, following the MoU signed between the two Universities for the first time in 2011 and renewed for two times (2011-2015 and 2015 -2022), both parties enter this agreement for the purpose of enhancing the educational and research opportunities and exchange of their students and faculty. More specifically, this Agreement will promote:

- opportunities for qualified students enrolled at one university to study
   at the other university, and in such opportunities, student transfers will meet admission standards
   established by the respective institution;
- the development of cooperative endeavors in research and education and the sharing of faculty and research scholars for such purposes;
- the identification of commonalities which will nurture the relationship between these two universities;
- the exchange of educational and cultural materials of mutual interest to both universities;
- 5. the recognition of each other as institutions that can and will provide attractive "study abroad" opportunities for students based upon the similarity of missions, such as semester exchange program, summer camp, lecturers exchange, etc. And mutual commitment to

international understanding through education, research, and service;

6. the possibility for students to study the educational master's/doctoral degree

program and joint master's/doctoral degree program by using the resources of both parties carrying out the educational activities, under the single curriculum agreed by the parties;

This Agreement does not commit or imply any financial obligations on the part of either institution. Unless otherwise and specifically agreed to in writing and signed by both parties

as a formal modification to this Agreement, each university is responsible for any expenses it may incur as a result of this Agreement.

This Agreement will remain valid for 5 years after it has been signed by the authorized signatories of both parties. In case of termination, the programs or the activities that have already been approved by both parties by the date of the written notice shall be allowed completion under the conditions of the Agreement.

More detailed agreements between individual colleges and/or academic units may be added as appendix to this Agreement. The Agreement shall be reviewed during the fifth year to evaluate the progress and the quality of the mutual cooperation.
