

Agreement of Scientific Cooperation  
between the Aristotele University of Thessaloniki,  
Greece and the Technical University of Gdańsk, Poland

The undersigned 1) Dimitrios A. Fatouros, Rector and authorized representative of the University of Thessaloniki and 2) Eugeniusz Dembicki Rector and authorized representative of the Technical University of Gdańsk, accept the following Agreement of Scientific Cooperation between the above mentioned Universities.

Article I

1. Seminars and Lectures

Each one of the cooperating Universities undertake the responsibility of exchanging up to eight(8) visits of the scientific staff every year. Eight(8) Gdańsk scientists can visit Thessaloniki and eight(8) Thessaloniki scientists can visit Gdańsk. The duration of each visit is defined to seven days. The Lectures to be given during these visits concern the scientific activities of the following Departments of the two Universities:

- a) A.U.Th : Electrical Engineering, T.U.G.: Electronics  
Sector of Telecommunications  
(Acoustics, Telemetry, Biotechnology)
- b) Architecture  
Sector of Architectural Design and Technology  
(Architectural Acoustics)

The Lectures and Seminars will be given either in the Language of the receiving country or in one of the following languages: English, French, German. In the latter case it would be advantageous the existence of simultaneous translation according to a previously submitted manuscript.

2. Joint research programmes.

Members of the scientific staff of the above Universities could participate to joint research programmes of common interest. The results of these programmes should be reported in common publications to mutual benefit.

3. Exchange of Publications and Reports between the cooperating Universities.

4. Every year, six months before the beginning of the academic year, a Committee consisting of two authorized representatives, one for each University, will submit a detailed programme for the joint cooperation. This programme will include the names of the scientists, who will participate to the mutual exchanges, the scientific topics to be covered, the detailed time plan of their travels and the Institutes and Laboratories which will cover the research activities.

The members of this Committee as well as their substitutes will be defined by each University after the confirmation of this Agreement.

Article II


Each University will cover the travelling expenses of its scientific staff, while the accommodation expenses will be covered by the receiving University. The receiving University will cover also travelling expenses within the country to places other than Thessaloniki and Gdańsk, provided these travels are included in the programme of each year.

This Agreement valids for two years, starting with its signature and can be extended after common decision and agreement of the two parts.
