## Article 1

In the interest of further cooperation, in line with and based on the Agreement on Cooperation concluded between the University of Belgrade and the Aristotle University of Thessaloniki on March 23, 1996, last time renewed on March 19, 2014 (hereinafter "Agreement") aforementioned institutions of higher education have agreed to establish a program of exchange and collaboration in areas of interest and benefit to all parties.

The Annex of the Agreement takes into account mutual interest in field of Classics research and development. With this Annex of the Agreement, the parties listed above seek to secure the continuous attention to coordination and synergies as well as to practical and financial solutions that are beneficial to the cooperation between the Aristotle University of Thessaloniki -Faculty of Philosophy and the University of Beograd-Faculty of Philosophy.

#### Article 2

The Aristotle University of Thessaloniki-Faculty of Philosophy and the University of Beograd-Faculty of Philosophy agree as follows:

- 1. to undertake cooperation related to joint research activities;
- 2. to jointly organize lectures, seminars and academic meetings;
- 3. to organize exchange of faculty members;
- 4. to organize exchange of students;
- 5. to cooperate in other areas in which concrete mutual interest in cooperation is established or will develop.

# Article 3

The Aristotle University of Thessaloniki-Faculty of Philosophy and the University of Beograd-Faculty of Philosophy shall designate Liaison Officer each to develop and coordinate the realization of specific activities or programs.

### **Article 4**

All commitments, obligations and expenditures related to projects approved under this Annex to the Agreement shall be obligations of the Aristotle University of Thessaloniki-Faculty of Philosophy and the University of Beograd-Faculty of Philosophy.

By signing this Agreement the Parties assume no financial liability.

### Article 5

This Annex to the Agreement shall be legally binding while the Agreement remains in force from the date of the last signature. This Annex to the Agreement may be terminated by either party giving six (6) months written notice to the partner institutions.

This Annex to the Agreement has been drawn up in twelve (12) equal originals, four (4) of which in English, four (4) in Greek and four (4) in Serbian language.
