AGREEMENT OF COOPERATION

between

Karaganda Economic University of Kazpotrebsoyuz

(9 – Akademicheskaya str., Karaganda, 100000, Kazakhstan) represented by

Rector, Prof. Dr. Yerka Aimagambetov

and

Aristotle University of Thessaloniki

(54124 Thessaloniki, Greece) represented by Rector, Prof. Pericles A. Mitkas

ARTICLE 1

The purpose of this agreement is to establish cooperation between Karaganda Economic University Kazpotrebsoyuz and Aristotle University of Thessaloniki.

ARTICLE 2

Both of the Universities, based on the available financial capacity, will seek to promote:

- 1) the exchange of teachers, scientists and staff on short-and medium-term programs;
- 2) collaborative research;
- 3) improving the skills of teachers;
- 4) compilation and translation of textbooks and teaching materials;
- 5) improving the management structure of universities;
- 6) joint seminars, conferences, symposia, etc.;
- 7) the exchange of students and specialists of postgraduate forms of training;
- 8) the exchange of publications on the entire range of cooperation issues.

ARTICLE 3

The detailed program of cooperation, stated in Article 2, will be determined every two years by the Universities' Administration or their representatives (responsible for the external relations of the Universities).

To implement the activities stated in Article 2 both of the Universities will try to find funding resources from their own budget as well as from national and international organizations.

Transportation costs will be borne by the sending side.

Funding for the implementation of programs will be determined by separate agreements for each year of this Agreement's validity.

ARTICLE 4

This Agreement come into effect from the moment of its signature by both parties and is valid for five years. Each of the Parties may refuse from continuing the cooperation by formally notifying the other party in the period from the 1 to 15 of November of the current calendar year of the Agreement validity.

If such kind of notice is not received the Agreement will be extended automatically.

Termination of the Agreement does not entail the discontinuance of the work on previously agreed and approved programs until their full completion.
