Considering

That both Institutions are developing a fruitful cooperation and, aware of the need to promote the development of research and other academic and cultural activities, contributing to the scope of institutional goals,

the Institute for Advanced Studies in Levant Culture and Civilization and the Aristotle University of Thessaloniki agree in the celebration of the present Agreement, as follows:

The present Agreement is intended to promote the co-operation between both institutions in order to achieve together academic, scientific and cultural activities in areas of mutual interest.

By signing this framework Partnership Agreement, the Parties express their accord for association, indefinitely and in accordance with the provisions of the national and European legislation in force, in order to organize common activities in the ISACCL's fields of activity, such as: scientific research on cultures and civilizations in the historical

The Partners will work together to develop their own projects as well as to participate to the implementation of programs and projects with national or international funding, in the agreed cooperation fields. Also, the Partners will make proposals for improving and diversifying the activities undertaken in the framework of the present Partnership Agreement.

This Partnership Agreement does not limit in any way the right of the Parties to participate in other forms of partnership with third parties.

The Title to Intellectual Property on the results of the partnership, reports, and other related documents will remain the property of both Partners.

The signing Parties to this Partnership Agreement consent to keep confidential the information received during the implementation of the Partnership activities and agree to prevent any unauthorized use or disclosure of such information.

During the validity of this Partnership Agreement, the Parties will have the right to concur in writing on the amendment of certain clauses, by an additional act, whenever their interests require or when these circumstances occur and could not have been foreseen when the present Partnership Agreement was concluded.

The Partnership Agreement becomes effective from the moment of its signing. None of the contracting Parties may unilaterally modify and/or complete this Partnership Agreement.

The Parties understand and accept that the Partnership Agreement ceases, within the time limit of at least 15 days set by law, upon written notice of any Party or by mutual agreement of the Parties.



